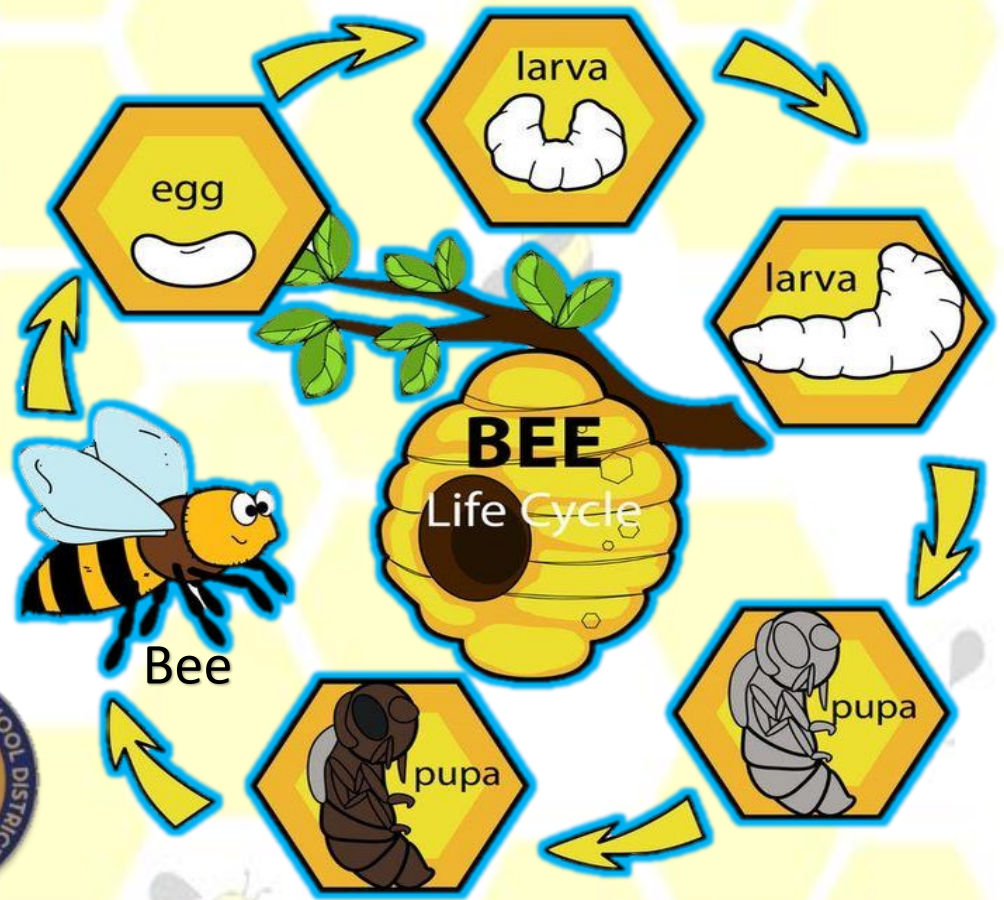

Fresh Fruit & Milk Served
